Privacy

Wine Corner Ltd is committed to protecting your privacy. We will only use information that we collect about you lawfully, in accordance with the Data Protection Act 2018, UK GDPR (01/01/2021) and the EU GDPR (25/5/2018).

We are registered under the Data Protection Act 2018 and comply with all three of the above regulations in all our dealings with your personal data.

We collect information about you for 2 reasons: firstly, to process your order and second, to provide you with the best possible service and advise you of any recalls issued by manufacturers of products that you purchase from us.

We will never share personal information with third parties unrelated to us.

We will not e-mail you in the future unless you have given us your consent.

We do not collect any information about you except that required for processing your order.

The type of information we will *collect* about you includes:

- Your name
- Address
- Phone Number
- E-mail Address
- Order Information
- Credit/Debit Card Details

Credit card information is *recorded* by use of a secure SSL server using 256 bit encryption as used by most of the world's banking organisations.

For the security of our customers, *we do not store credit card numbers*. Credit card numbers are only passed on to our payment service provider.

The information we hold will be as accurate and as up to date as possible. You can check the information that we hold about you by writing to us. If you find any inaccuracies, we will update our records as soon as possible.

The personal information which we hold will be held securely in accordance with our internal security policy and the law.

Policy

This Cookie Policy outlines how Wine Corner Ltd ("we," "us," "our"), uses cookies and similar tracking technologies on our website accessible at <https://www.winecorner.co.uk/> ("the Website"). 1. What are Cookies?

Cookies are small text files that are stored on your device (computer, smartphone, tablet) when you visit a website. These files enable the website to remember certain information about your browsing activity, preferences, and interactions. Cookies can be either first-party cookies (set by the website you are visiting) or third-party cookies (set by external domains).

2. How We Use Cookies

We use cookies on our Website for various purposes, including but not limited to:

- **Essential Cookies:** These cookies are strictly necessary for the proper functioning of our eCommerce platform. They allow you to browse our Website, add products to your cart, and make secure purchases.
- **Performance and Analytics Cookies:** These cookies collect anonymous data about how visitors use our Website, such as which pages are frequently visited, the time spent on each page, and any error messages encountered. The information gathered helps us analyse user behaviour and improve the Website's performance and functionality. This website uses tracking software to monitor its visitors to better understand how they use it. This software is provided by Google Analytics which uses cookies to track visitor usage. The software will save a cookie to your computers' hard drive in order to track and monitor your engagement and usage of the website but will not store, save or collect personal information. - **Functionality Cookies:** Functionality cookies remember your preferences and choices to enhance your shopping experience on our Website. For example, they can remember your login credentials, language preferences, and selected currency.
- **Advertising and Targeting Cookies:** We may work with trusted advertising partners who use cookies to deliver personalised ads to you based on your interests and browsing behaviour. These cookies help us show you relevant product recommendations and promotions.
